This hearing is in response to the petition of Boston Gas dba as National Grid, seeking permission for the following:

To install a new gas Regulator Station on Walnut Street (near the intersection of Summer Avenue) to replace an existing Regulator Station on Summer Avenue.

Also, consent to the locations of mains and structures for the transmission and distribution of gas in and under the public streets, lanes, highways and places of the Town of Reading and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place

Said work to be done substantially in accordance with the petition(s) and plan(s) filed in the office of the Town Engineer, lower level of the Reading Town Hall.
